How can you destroy NGOs in Russia (on the example of the "GOLOS" Association )



On June 26, 2013 the Association of NGOs "in defense of voters' rights "GOLOS" found out from the media about the decision taken by the Justice Ministry to suspend the activities of the Association.



# The steps of this special operation are carefully followed.

**On March 15, 2012**, immediately after the Presidential Election, an online petition emerged, calling for the adoption of a so-called "law on agents". The petition is hosted at <u>http://podkontrol.ru/</u>.

"Today technologies of "soft power" are applied against Russia. An undeclared information warfare is being conducted, involving hundreds and thousands of people, agencies and organizations. Using the imperfection and the backwardness of Russian legislation, the multi-million dollar budgets are allocated through foreign funds to finance activities aimed against Russia. Billions of dollars are spent to undermine the integrity of Russia, and the stability of its political foundations. The recipients of these budgets disguise themselves in "sheep's clothing" of non-profit human rights and analytical organizations. In reality, they function as subversive structures, and even directly finance activists of radical political movements".

"GOLOS" could not skip this petition and could not refrain from exposing the counterfeiters:

### Roman Udot is conducting an online investigation titled: *"Counter cheat of national importance"*

"Falsifiers were exposed again. It was determined that on the website podkontrol.ru, which was calling for greater transparency in the activities of NGOs, there was a falsified number of signatories. It was estimated that the number of signatories was higher in... 13 times!" Registrar of the website is listed as an unnamed "private individual".

### **Cheaters and thieves always leave traces**


"So, 100 000 signatures must be collected, but where can we find them? But if necessary... And now we can see 97 435 "signatures" (as of 5 July, 2012, 20:06 ).

The petition could have been signed directly or through the social media: Facebook, VKontakte, Twitter and Mail.ru. And finally, we could find traces of this twitter activity on Yandex!"

Here is our first signatory:



There were only **733** similar messages. **733 messages since March 2012.** It is not enough for the whole **ninety thousand army**. Something is not right. It is perfectly clear what a "nationwide" support gained this idea. On the first day, after a tweet of xs\_71 a further 70 signatures arrived. Then - a record of 90, and then a sudden decline. It is clear that these are purchased (motivated) signatories, as social projects do not develop in such manner. In order to attract supporters, more time is needed, the peak cannot be achieved immediately.



We can also see what happened to the project, when the budgets were exhausted (motivation dried up). When asked to pay for tweets, people were not fascinated by the idea. The first tranche of money was gone in the sand. But we can see that before considering the bill in Duma, the second tranche arrived. Congratulations. The second tranche, as we can see, has been successfully exhausted.

What is the quality of these "signatories"?

Not only that a petition was signed by a little-known "Angry Pandas" or commonly known "Priests Gapons", but they did it **more than once**.


But we must pay tribute to the intra-corporate ethics of world's Internet-crime. Most of the carousel voters signed only two times. Everything is fair: one tranche - one signature.

You can make sure by yourself that there are only 612 (out of 733) unique Twitter signatories. It means that 20% of the votes were collected by a carousel voting.

Therefore, the most interesting part follows ahead.

According to the research by All-Russian Center for the Study of Public Opinion (VTSIOM) (http://www.ferra.ru/ru/techlife/news/2012/02/14/wciom-Facebook-Twitter/), the proportion of Twitter users in spring of 2012 reached **9%** in Russia. Based on this data, it is easy to "retrace" a number of "real" signatories.

Below graphic presents the estimate of the number of signatures from the entire Runet (**blue dots**), determined by the activity of its 9 % Twitter users.



"In the aftermath of April 5, 2012, when the first tranche was exhausted and paid (motivated) signatories run out, the counter was spinning without ceasing. 33970! 45428! 50698! The cheaters even do not realize that real social processes do not normally develop in such a linear way. There is no activity, but the counter is spinning and spinning. This can only happen if the counter has nothing to do with the activity. It is an autonomous, sovereign counter".

Be thoughtful! There were 733 tweets-signatures in total. It means that total number of signatories can be estimated as 8144 (733/9%\*100%)

**8144, but not 97 435!** (as of July 5, 2012, 20:06). It means that nearly 90 000 or 92 % of signatures were falsified. Such machinations were not dreamed even by "magician" Churov!

### Chronicle of events.

**On July 6, 2012**, once the counter of "signatures" by fictional characters such as "Boniface Ptiburdukov" reached 100 000, the State Duma adopted the **"law on agents" in the first reading.** 



# On July 13, 2012 the law was passed in a big hurry right away in two readings.

The main idea of the law is the requirement for non-profit organizations to register as "foreign agents" if they receive foreign funding and are engaged in **"political activities"**.

The law was adopted in such a hurry that it contains a number of omissions, inaccuracies and ambiguities: not spelled out the procedure of transition from "foreign agents", and it contains references to vague definitions such as "political activity", "public policy".

Nevertheless.

**On November 21, 2012** the law came into power.

**On April 9, 2013 the first protocol of administrative offence against the "GOLOS" Association** was issued by the Justice Ministry. The Association was accused of receiving 7728,40 Euro in prize money after being presented the Andrei Sakharov Freedom Award from the Norwegian Helsinki Committee.



**On April 25, 2013** two hearings were held, during which representatives of the Association and its head presented compelling evidence that the Association had not received the mentioned funding, as well as other funding from abroad since the Law came into force. *However, the court supported the Justice Ministry's position. The "GOLOS" Association was fined 300 000 rubles and its head was fined a further 100 000 rubles.*
